The Leelanau County Board of Commissioners meets at 7 p.m. on the third Tuesday of each month at the County Government Center. Commissioners also meet on the second Tuesday of each month at 9 a.m. as an Executive Committee of the Whole, which is only authorized to make recommendations that are taken up at commissioners' regular meetings.

The two-year terms of present commissioners run until December of 2012.

Primary and General elections will be held in 2012 for the County Board. Positions are partisan, meaning that most candidates sign up for the Primary Election in August seeking to run as the nominated candidate for the Republican Party, Democratic Party or some other political party. Nominating petitions or a \$100 filing fee must be submitted to the County Clerk in May.

Candidates without political party affiliation must file qualifying petitions in July to have their names placed on the General Election ballot. Candidates may also run as write-ins with a later sign-up deadline.
